

SUMMARY OF REGULATIONS ADOPTED BY THE COMMISSION ON PROFESSIONAL STANDARDS IN EDUCATION

Effective: April 29, 2026

- [R066-24](#) – Changes to NAC 391.XXX.
 - Allows a person to obtain a 3-year provisional license for official transcripts if they have completed all academic requirements for their program.
- [R032-25](#) – Changes to NAC 391.036; 391.425; and 391.13065.
 - Clarifies that a person must have experience in a Business or Industry which relates to the program for which he or she is applying for an endorsement.
 - Repeals NAC 391.13065 Endorsement to teach automotive service technology: Qualifications; provisional endorsement; credit toward renewal of license.
- [R033-25](#) – Changes to NAC 391.055; 391.059; and 391.242.
 - Requires a person to hold a base teaching license and a bilingual endorsement before teaching in a program of bilingual education.
 - Requires a person to pass a competency exam approved by the Commission, at the level approved by the Commission which demonstrates that the person has oral and written proficiency in the native language prior to obtaining a bilingual endorsement.
 - Repeals NAC 391.059 Testing or assessment of teacher assigned to program of bilingual education; maintenance of records; annual report.
- [R034-25](#) – Changes to NAC 391.229; 391.237; 391.323; and 391.420.
 - Conforming language updates for the Cultural Competency, Social Emotional Academic Development, and English Language Acquisition Development endorsements.
 - Allows all license holders to obtain these endorsements.
- [R035-25](#) – Changes to NAC 391.420; 391.0897; and LCB File R128-22.
 - **Creates additional specific endorsements in the area of Ethnic Music, Ethnic Dance, and creates a Musical Instrument Technology and Repair endorsement.**
 - Allows these license holders to obtain an endorsement in Cultural Competency, Social Emotional Academic Development, and/or English Language Acquisition Development.
- [R038-25](#) – Changes to NAC 391.146; 391.148; 391.150; 391.152; 391.154; 391.156; and 391.158.
 - Repeals NAC 391.146 Exception defined.
 - Repeals NAC 391.148 Applicability of provisions.
 - Repeals NAC 391.150 Submission of lists: List of teachers and teaching assignment; list of teachers teaching outside area of endorsement.
 - Repeals NAC 391.152 Request for exception: Submission; form and contents; objection.
 - Repeals NAC 391.154 Request for exception: Action by Superintendent of Public Instruction.
 - Repeals NAC 391.156 Period of exception; extension of period.
 - Repeals NAC 391.158 Limitation on teaching of courses related to area of endorsement.

- [R040-25](#) – Changes to NAC 391.367.
 - Allows a special education generalist or physical education license holder to obtain an endorsement in Adaptive Physical Education.
- [R067-25](#) – Changes to NAC 391.060 and NAC 391.073.
 - With the exception of the Emergency Substitute license, aligns all licenses to 3-year provisional, 5-year standard, or 6-year professional.
 - Allows other license educational personnel to obtain a retiree license after meeting certain requirements.
- [R068-25](#) – Changes to NAC 391.063.
 - Allows a license holder to voluntarily surrender an endorsement by submitting a request to the Department without a notarized statement.
 - Requires a license holder to voluntarily surrender their license to submit a request to the Department with a notarized statement.
- [R098-25](#) – Changes to NAC 391.036.
 - Allows a license holder to waive the basic competency (Praxis Core) exams by taking and passing approved course(s) with a grade “B” or better before or after attempting the exam(s).
- [R100-25](#) – Changes to NAC 391.XXX and NAC 391.057.
 - Allows an alternative route to licensure license holder to change their area within the first year of issuance while remaining employed, pending the new endorsement issuance, if reassigned to an assignment outside of their licensure area.
 - Allows an employer to count the license holder a teaching in-field pending issuance of the new endorsement area.
 - Requires the employer to reimburse the license holder the licensure fee costs if assigned to a new assignment outside of the holders current area.
